Agreement Requirements:

1. Sandy Beach Regional Park (SBRP) gives the Tenant (gardener) permission to use the designated portion of land (plot number) as communicated by the Sandy Beach Regional Park Representative. The plantings must be confined to within the staked area of the gardener's assigned plot.
2. The term of the Agreement shall be for the period of May 1 to October 31.
3. The Gardener will pay a non-refundable fee of \$50.00 to be paid in full when and presented with the signed agreement. All gardeners wishing to obtain a year-round plot will pay a non-refundable \$75.00 and should indicate their intention of a year-round plot on this application.
4. The Gardener agrees to maintain the garden plot and keep it in a relatively weed-free state to keep weeds from spreading to other plots. Failure to do so will result in the mowing or turning over of the plot to prevent the spread of weeds with NO notice to the gardener. SBRP will not be liable to the gardener for any damage to the crops.
5. The Gardener agrees to care for and harvest the crop until the end of the season.
6. The Gardener agrees to dispose of all garbage, plant material, structures put up during season and debris from the garden in a proper manner on or before the October 31.
7. The Gardener will ensure that their family or invitees will cause no nuisance or disturbance to other gardeners or adjacent plots.
8. The Gardener release SBRP from any liability for any claims whatsoever arising out of damage to, loss of, or theft of the Gardener's property kept or stored on the garden plot, including the crops

grown in the plot, or any injury the gardener and their family or invitees may sustain while gardening on this property.

9. If the Gardener breaches or fails to perform any of the above points, then the Sandy Beach Board may declare the Tenant in default, declare the agreement null and void and repossess the plot.
10. The Gardener shall not use herbicides or pesticides.
11. The Gardener will respect fellow renters by only walking on lawn areas or paths between plots.
12. If the Gardener is away or unable to tend to their plot, they should make arrangements to have someone tend to it and/or notify the Community Garden Representative and the plot will be reassigned.
13. If any of the above-mentioned terms are not being upheld, and after a reasonable amount of time the situation does not improve, the garden plot will be plowed up and the renter's garden privileges will be revoked. The Gardener will also forfeit eligibility to rent a plot for the following season.
